



Dell EMC CloudIQ streamlined the user experience in five cloud-based storage preventive management tasks

This document describes what we tested, how we tested, and what we found. To learn how these facts translate into real-world benefits, read the report Dell EMC CloudIQ streamlined the user experience in five cloud-based preventive storage management tasks.

We concluded our hands-on testing on April 13, 2020.

System configuration information

We completed our testing on storage solutions hosted remotely in the Dell EMC lab. Both solutions had a comparable number of servers, storage processors, and disk shelves.

How we tested

Dell EMC provided a VMware environment hosted on the rack servers for each storage solution. Using HCIBench and Vdbench, we created three workload profiles to simulate typical business activity:

- Steadily increasing storage writes over a 24-hour period to simulate logs, new customers and orders, and other cumulative data
- Bursts of mixed I/O at the end of each day to simulate close-of-business sync operations
- High demand mixed I/O at random times to simulate unexpected traffic and an increase in storage activity

We used the workloads above to test the Capacity Approaching Full and Performance Impact and Anomaly Detection features of Dell EMC CloudIQ. To test the Reclaimable Storage feature, we created one additional HCIBench VM per solution, ran a database mix for 2 hours, then disconnected the LUN from the host. Using Iometer, we also created two Microsoft Windows VMs (per solution) running heavy sequential write workloads to test the noisy neighbor identification feature. To test the non-highly available host, we disconnected a host bus adapter on one of the storage processors in each solution.

Timing and steps

In this section, we present the exact times and steps our technician needed to find each feature we tested, starting once they were logged into the storage management tool. CloudIQ, which we used on the Dell EMC Unity XT array, provided some of these features on the overview screen that appears immediately after logging in. We've used one step and 1 second to account for our technician getting oriented and locating the information. On HPE InfoSight, which we used on the Primera array, many of the features did not exist and didn't have a direct comparison at the time of testing. For those cases, we recorded the time and steps for an admin to perform the closest-match workflow on HPE InfoSight for the Primera array, which in all cases meant that we used the SSMC virtual volume performance overview.
