## **COMPARISON OF 13-INCH-CLASS 2-IN-1 LAPTOPS**

We compared the Dell<sup>™</sup> XPS<sup>™</sup> 13 2-in-1 to others in its class from vendors including Acer<sup>®</sup>, ASUS<sup>®</sup>, Fujitsu<sup>®</sup>, HP, Lenovo<sup>®</sup>, Microsoft<sup>®</sup>, and Samsung<sup>®</sup>.
